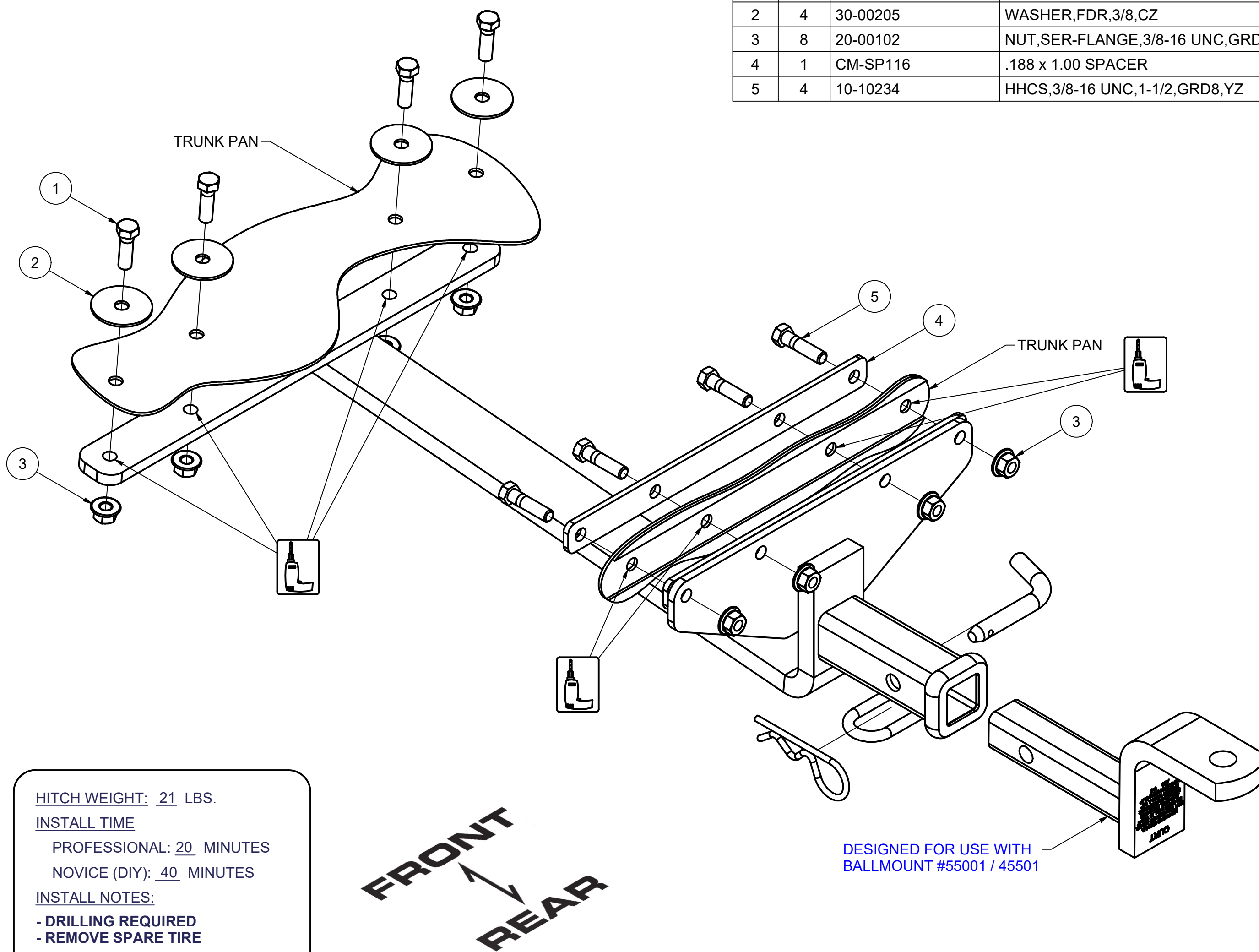

**INSTALLATION STEPS**

1. Temporarily remove spare tire and jack from trunk.
2. Place reinforcement plate on the lip, inside of trunk as shown. Plate must be located going left to right in center of car. Note: Center of trunk pan is not center of car.
3. Mark trunk for fasteners. Remove plate, centerpunch, and drill. Install fasteners as shown.
4. Using hitch as a drill template, drill remaining mounting holes and install fasteners as shown.
5. Return spare tire and jack to trunk.
6. Torque all hardware to 45 lb.-ft.
