

INSTALLATION STEPS

- 1. Remove the tie down brackets under the vehicle at the outside corners. The driver side is attached with (3) 8mm bolts, and the Passenger side is attached with (4) 8mm bolts. Return the tie down brackets and fasteners to the vehicle's owner for reinstallation should the hitch ever be removed.
- 2. Install the main body weldment (item 8) in place of the tie down brackets using the fasteners as shown. The safety chain bracket on the main body weldment will face towards the rear of the vehicle. Be certain to install the conical tooth washers and bolts against the brackets with teeth away from the bolt head.
- 3. Position the tail bracket weldment accross the top of the main body weldment and fasten to the tongue as shown. Do not fully tighten yet.
- 4. Adjust the hitch so that it is square with the vehicle. Clear the rear cargo area of spare tire and other items. Using the hitch as a template, drill the vehicle floor (4) places for 3/8" bolts.
- 5. Fasten the hitch to the vehicle floor using fasteners as shown; making sure to use fender washers inside the trunk, opposite the floor.
- 6. Torque all 8mm fasteners to 23 lb-ft, all 3/8" fasteners to 45 lb-ft, and all 1/2" fasteners to 110 lb-ft.
- 7. Apply silicone sealant around fasteners installed in trunk to seal out water and exhaust fumes.
- 8. Reinstall spare tire and trunk contents removed in step 4. **PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.**
